## TUITION TOTALS:

Tuition for 2024-2025 for **Kindergarten** is **\$7,920** total or **\$660 per month** (12 payments).  
 Tuition for 2024-2025 for students in **grades 1-5** is **\$11,940.00** total or **\$995 per month** (12 payments).  
 Tuition for 2024-2025 for students in **grades 6-8** is **\$12,660.00** total or **\$1,055 per month** (12 payments).

## ENROLLMENT FEES:

## PAYMENT SCHEDULE

- Annually** One payment of the total tuition amount by July 1<sup>st</sup>, 2024.
- Semi-Annually** One payment of half the tuition amount by July 1<sup>st</sup>, 2024; the second payment due by January 1<sup>st</sup>, 2025.
- Monthly** Twelve equal monthly tuition payments, beginning July 1<sup>st</sup>, 2024 and continuing the 1<sup>st</sup> of each month through June 1<sup>st</sup>, 2025.

## TERMS OF THE CONTRACT, LATE FEE POLICY & GATEWAY DATES

### *Early Withdrawal*

A 30-day written notice must be received for early withdrawal of students. Families are responsible for tuition during the final 30 days, even if their child is no longer receiving instruction in the class. Families withdrawing between July 1<sup>st</sup>, 2024 and the first day of school in September 2024, are liable for one month's tuition.

### *Late Tuition Fee*

A \$15.00 late fee is charged to a family's account when monthly tuition is received after the 10<sup>th</sup> of the month. Tuition is due the on 1<sup>st</sup>. There is a 10-day grace period.

### *Gateway Dates: September 1<sup>st</sup>, January 1<sup>st</sup>, & May 1<sup>st</sup>*

September 1<sup>st</sup> A child may not start the school year unless their tuition is up to date as of September 1<sup>st</sup>.

January 1<sup>st</sup> A child may not continue for the second semester if their tuition is not paid up by the first day back after Winter Break.

May 1<sup>st</sup> To be considered for tuition assistance for the upcoming year, a family's tuition must be current on May 1<sup>st</sup> when the tuition assistance committee meets to process requests. A family whose tuition is not current, loses the possibility of receiving assistance for the upcoming school year.

## LIABILITY, FIELD TRIP & MEDIA WAIVERS

I, the above signed, agree to abide by the protocols and policies of the school. If I have issues or concerns, I will follow the Protocol of Concerns in addressing those issues. \*

I, the above signed, hereby consent to my child(ren) participating in any field trips taken by their class or as a member of a school group. These field trips may be taken on foot, bicycle, bus, or by private car to a desired location. This permission is granted for all trips for the 2024-2025 school year. I will advise the school in writing if permission is withdrawn at any point during the school year.

I consent to my child(ren)'s participation in classes, activities, field trips, and other school sponsored events on and off campus of The Siskiyou School. I acknowledge that participation in these activities may expose the above named child to the possibility of injury. I hereby give permission to the teachers and staff of the school to seek medical attention for the child in the event of an illness, accident, or injury during school activities or field trips.

I acknowledge that students participating in handwork, woodworking, gardening, and other activities important to the education offered at The Siskiyou School will expose them to sharp objects, needles, and tools. I acknowledge that they may also be exposed to challenging physical movement. I acknowledge that neither The Siskiyou School, nor its employees will be held responsible for injuries sustained at the school or on field trips. I hereby waive and release The Siskiyou School and its employees from any and all liability claims, demands, actions and/or damages that occur while attending classes, field trips, and school events, and assume all responsibility for named student, should an injury, accident or illness occur.

I, the above signed, do hereby consent to my child being photographed during school activities, field trips, and other school sponsored events on and off campus of The Siskiyou School. I understand that my child may appear in media sources on behalf of The Siskiyou School. I will advise the school in writing if permission is withdrawn at any point during the school year.
